### **Attempted Homicide - Officer-Involved Shooting**

On Monday, March 27, 2023, at about 10:30 AM, Chandler Police responded to the 800 Block of North Santa Anna Street, when a victim called police to report that she had been shot by her ex-boyfriend, Alan Burgener. She was transported to a local hospital with a non-life-threatening injury.

Just after 11:00 AM, Police received a 911 call from a resident at a nearby apartment complex who reported that a male subject had broken into his apartment and was armed with a gun. The subject matched the physical description of Burgener, and he later stole their vehicle. Officers and Detectives worked throughout the rest of the day and night to locate Burgener.

On Tuesday, March 28<sup>th</sup> at about 12:27 PM, a citizen near the 700 block of North Dobson Rd. called 911 to report that she had seen a subject who matched Burgener's description, and officers responded to the area. Additional callers began reporting that this subject was running and jumping various residential walls in a nearby neighborhood.

The last yard the subject entered was in the 2200 block of West Shannon Street. As officers surrounded this house and entered the yard, they heard a female inside screaming.

As officers quickly made plans to breach the home to rescue the homeowner, they saw the victim come out to the balcony of her home, visibly upset and crying, saying that the subject was inside her home and was going to shoot her.

Shortly after, the subject came out to the balcony with the victim. The subject re-entered the residence, where an officer outside a window saw the subject with a firearm in his hand. The officer, in imminent fear for the lives of the victim, other officers, and himself, fired 3 rounds at Burgener from his department-issued rifle.

Officers entered the home and located Burgener inside the 2<sup>nd</sup> story bathroom. A handgun was found concealed in the bathroom with Burgener.

The original shooting victim was seriously injured but is recovering from her injuries. No other citizens or the suspect were injured during this incident.
